

Minutes of Executive Meeting of Maryland Section of the American Chemical Society Virtual Meeting on Zoom Chair Sarah Zimmerman, presiding October 10, 2022

We did not have a quorum for this meeting.

Sarah called the meeting to order at 7:05 p.m.

Saif Yasin of UMBC described the Fair for Emerging Researchers (FER) program he has worked with in the New York and the New Jersey sections. FER is for 5-8 grade students, encouraging them to think out science projects, not just do demos. In this project-based learning program the first step is recruiting students and signing them up with mentors. The students are coached through the steps of the scientific method, asking good questions, finding sources, crafting a hypothesis, considering experimental design, and data analysis. This involves 6 hours of participation per student, including a 30 minute/week assignment. The students present their projects online on March 18th (in 2023) from 10 a.m. to 4 p.m. Saif would like to recruit judges in our section for March 18 (8 am - 2 pm commitment). He is interested in recruiting students to help with mentorship; this is a 20 hour volunteer position. He would like help reaching out to elementary and middle schools for participation, and would also like any funding our section can provide. An overview slide can be found at the end of these Minutes.

Dr. Tom Muir, the 2020 Remsen awardee, will present a lecture at Johns Hopkins University on Oct. 13 at 6 p.m. This was postponed until this year due to COVID. A full description of this event is on p. 9 of the current Chesapeake Chemist.

The Braude Award will be given to Dr. Dianne Luning-Prak on Monday October 24 on Zoom at 6:30 p.m. Dr. Luning Prak will be given her framed certificate and then will make a presentation about her research.

Beatrice has a nominee to suggest for the Maryland Chemist Award for December.

Kelly reported that Rebecca Ruck, an Associate Vice President at Merck, will speak to the Women Chemist Committee on February 8 online.

Michele reported that the Ice Cream Social at the Charmery, previously scheduled in September, is now rescheduled for Nov. 5 at 2 p.m.



Jan reported that we have \$107,755.88 in our Nicholas Fund, and \$79,488.42 in our Fidelity Contra Fund. The balances in both funds are down since spring.

Lee gave the Treasurer's Report (attached at end). We have a balance of \$19,055.82 in our checking account. Twelve colleges/universities took us up on our offer of \$1500 to their chemistry departments. We also have \$61,696.30 in our Money Market account.

Lee would like some help with the Treasurer's work. Nicole Carbonaro volunteered to help with some of the communication with national ACS. Lee also pointed out we should keep an eye on our income, which happens to be down now, but sometimes increases greatly. We want to maintain our tax-exempt status. Lee will attend a Treasurer's Seminar to pick up any useful tips. We might consider hiring someone for tax preparation in the future.

Louise asked whether the Section would be funding student travel grants for the national ACS meeting in Indianapolis in March 2023. The attendees were in favor of offering these grants again this year.

Rose Pesce-Rodriguez asked for \$518 for her work with chemistry programs at public libraries; it was approved.

Kelly is the only Councilor whose term expires in December 2022. She would like to run for that office again. Sarah will work with Eric Cotton on setting up the election. She would also like to have approval of the by-laws updates on the ballot also. We need to recruit one or more members to run for Chair Elect.

The 2023 MARM will be in Queens, NY June 9-10 at NY-QUNY. The organizers may ask for some help.

There was discussion about a Younger Chemists Committee for our Section. Beatrice and Sara encouraged us to try to recruit younger members, for example at our universities or work places. Some ideas that might draw younger members is working with the FER program Saif described at the beginning of this meeting, or perhaps a social event.

The meeting was adjourned at 8:28 p.m.
