

Minutes of Executive Meeting of Maryland Section of the American Chemical Society Virtual Meeting on Zoom Chair Jiangnan Peng, presiding May 6, 2024

Jiangnan called the meeting to order at 6:05 p.m.

The Minutes of the last (February 2024) meeting were examined. A motion was made, seconded, and passed to accept the February minutes.

Eric gave the Treasurer's Report (attached). Beatrice had a few modifications related to the Olympiad. Eric moved that, to simplify bookkeeping, checks we issue that are not cashed within 180 days would no longer be valid. The motion was carried.

Lee filed our tax return. He is working on e-filing the 1099 forms for honoraria.

Beatrice thanked Eric for renewing our tax exempt status.

Jan reported that our Fidelity ContraFund has \$131,379.16 (as of 5/6/24, about a \$3000 increase over February) and our Nicholas Fund has \$164,247.04 (as of 5/5/24, about a \$200 decrease over February).

Regarding Project SEED (high school summer internships): Louise had previously requested (by e-mail vote) funding for another Maryland Section Project SEED student; that motion passed. The total now is \$12,500. Louise verified that all the students we are supporting are not receiving funds from any other source.

Louise reported that a Student Travel Award of \$500 was awarded for a student to attend the August national ACS meeting. No students applied for travel grants for the MARM in June. There are still two \$400 registration grants for attendees at the HalChem conference at Hopkins in Sept.

Sara reported that 80 people attended the Student Awards Luncheon at Notre Dame April 28, including six Section members. The awardees and parents were most appreciative. Tickets were not required, but \$377 in donations were collected.

Jiangnan is interested in developing a similar Awards event for high school students, perhaps including the winners of the Chemistry Olympiad.



AyseGul requested more e-mail contact. Many members are not receiving Constant Contact. Louise will contact Sarah Zimmerman, the person in charge of Constant Contact.

Olivia reported that Rowena Liu, her replacement as head of YCC, could not attend this meeting but Rowena plans to attend in the future. Olivia received a \$500 grant from the national ACS to help rejuvenate YCC. They will have a meeting May 14 on Teams to discuss revitalization. If Fall into Research is held again this year at Towson, YCC might be able to help judge. Sometime in the last two weeks of June Jason Dworkin of NASA will make a presentation at a Chem Café in an Annapolis library about Osiris Rex.

Merle Eiss is retired from ACS activities, so Stephanie will organize some recognition of our 50-60 year members.

Jiangnan thanked Beatrice for her wonderful work with the Chesapeake Chemist these last eight years. Jillian will take over the editorship.

Beatrice reported on the Chemistry Olympiad. About 52 Maryland students and 19 teachers participated from 16 schools. Eleven students advanced to the national competition, 3 made the Honors List, and one was elected to go to the camp where the students prepare for the international competition. \$1500 had been budgeted for the Olympiad. So far Beatrice has spent \$968. She still needs \$100 for goggles, \$130 for a banner, and some extra money to replace capillary tubes at CCBC, the Olympiad venue. The remaining \$532 should cover these expenses.

Rose reported on library events celebrating CCEW. There will be about 500 participants all told, and she has the library rooms reserved for fall for NCW. She requests \$600/year to support these activities. She also requested \$150 for the gift cards award to the ACS Poetry Contest winners.

Beatrice requests help finding nominees for Maryland Chemist of the Year by the end of Sept.

The meeting was adjourned at 7:07 p.m.
