

Minutes of Executive Meeting of Maryland Section of the American Chemical Society Virtual Meeting on Zoom Chair Beatrice Salazar, presiding February 12, 2025

Beatrice formally called the meeting to order at 6:02 p.m.

The Minutes of the last meeting, December 19, 2024, were approved with certain modifications to the Treasurer's report.

Several new attendees introduced themselves. Rigoberto has been elected President of the national ACS for 2026, which will be the 150th anniversary of the ACS, and Rigoberto would like to particularly highlight this anniversary at various institutions around Maryland.

Rowena is the new head of the Younger Chemists Committee. She is an undergrad at University of Maryland College Park and is open to suggestions for activities, perhaps coordinating with the District of Columbia chapter.

Tom is the Science Department Chair at Eastern High School, which is fielding a team of applicants for the Chemistry Olympiad.

Rachael is originally from Baltimore, but had been working in Tennessee. She has just recently returned to Baltimore.

Eric presented the current Treasurer's Report, attached to these Minutes.

Kelly proposed a possible distillery tour social event.

Ayse and Sunita attend the Leadership Institute in January. Ayse gave a report about that meeting.

The Maryland Chemist Award for 2024 will be awarded in February due to scheduling difficulties in late 2024.



Sara and Kelly reported that a speaker has been lined up for the Women's Chemist Committee meeting to be held on March 12 at 4 p.m. by Zoom. Travel money will not be necessary, but the speaker will receive a gift card.

Sara reported that the Student Awards Luncheon will be held on Sunday April 27 at the Maryland College of Notre Dame.

Louise reported that ten students had applied for Student Travel grants (generally \$500) for the 2025 spring national ACS meeting in San Diego, CA. Also four high school students have applied for \$150 registration grants for that meeting. This totals to \$5600, which was approved last December. In late January another student applied for a \$500 travel grant, and this was approved by e-mail vote. The Section website has since been amended so as to accept travel applications for the spring national ACS meeting between December 1 and January 15, and to accept travel applications to the MARM and the August national meeting between April 2 and May 5.

Concerning Project SEED, the program for high school internships, one professor at Morgan has submitted an application to the national ACS. If a student accepts this project, they will be paid \$4000, of which \$1250 comes from the Maryland Section. We also have a Maryland Section version of Project SEED for which students do not have to demonstrate financial need and receive a \$2000 stipend. We have four applicants for these internships.

Beatrice reported that 102 high school students have applied to take the qualifying exam for the Chemistry Olympiad. Our Section can now send fourteen students to the national exam; in previous years we could only send twelve.

Beatrice and Eric will work on amending certain fine points in the ByLaws.

We have received a Zoom account from the national ACS; Beatrice and Eric will work on getting it up and running.

Beatrice proposed a Nomination Committee. She suggests that Sunita would head the group which would include Sara, Eric, Lee Lefkowitz, and Rigoberto (tentatively). When Sunita becomes Chair, her place would be taken by Ayse.

Jan reported that our Fidelity ContraFund balance is \$165,686.15. Our Nicholas Fund balance is \$189,374.39.
